Introduction


Registration of workforce information is mandatory and regulated within many jurisdictions globally. In most cases, the process for collecting workforce registration information is completely manual and involves copy machines, physical papers and physical archives.

As the workforce registration information per definition is personal information, the handling and involved processes must comply to General Data Protection Regulation (GDPR), Know Your Customer (KYC) and more.

Principles of the solution

We offer a solution based on the Lequinox[®] Distributed Ledger Technology (DLT) that will simplify, secure and streamline all costly and manual processes in collecting workforce registration information.

The solution can be offered as a stand-alone solution (using a mobile phone/tablet) or integrated in existing management systems, all in compliance with local and national legislation, including GDPR, KYC and more.



- 1. Take photos of the personal information:
 - a. Personal ID.



- b. ID06 and more.
- 2. Take photos of the professional information:
 - a. Vocational certificates.
 - b. Eligibility certificates.
 - c. Security certificates.
 - d. Project training certificates.
- 3. GPS information is stored.
- 4. Enter additional information, if applicable.
- 5. Sign and Seal the collected workforce registration information.

- The Signed and Sealed workforce registration information is automatically encrypted, protected and stored in an own digital archive, including the irrefutable audit trail (who did what and when).
- The workforce registration information information is *automatically deleted* after a certain time, according to local and national legislation, GDPR, KYC, and more. The worker is informed when the information is deleted.

Improved workforce experience

During the registration of workforce information, the worker can, if applicable, have an exact copy of the registered information.

This includes information of deletion of specific information and a follow up mail confirming the deletion of the information and the connected email address.
